ORDINANCE NO. M2018-08-13

AN ORDINANCE TO AMEND THE STORMWATER MANAGEMENT ORDINANCE OF THE CITY OF MOODY, ALABAMA

WHEREAS, the City Council (the "City Council") for the City of Moody, Alabama (the "City") regulates stormwater discharge within the City and upon proposed development by way of a Stormwater Management Ordinance (the "Stormwater Ordinance")

WHEREAS, the Stormwater Ordinance creates a Permit Application Fee for industrial / commercial facilities; and

WHEREAS, the City incurs costs related to the enforcement of stormwater regulations for residential facilities; and

WHEREAS, due to the increasing costs associated with monitoring and regulating the requirements set forth in the Stormwater Ordinance, the Council has determined the Permit Application Fces established in 1998 are due to be revised.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moody, Alabama, while in regular session, on the 13th day of Avg, 2018, as follows:

Section 1: That Section 12-54 "Permit Application Fees" is hereby amended to state as follows:

Permit Application Fees:

(a) Each application for the issuance of a city stormwater discharge permit for an existing industrial or commercial facility shall be accompanied by a nonrefundable fee of One Thousand and No/100 Dollars (\$1,000.00) plus Fifteen and No/100 Dollars (\$15.00) per acre.

Said fee is good for one year and can be renewed for one additional year for a cost of One Hundred and No/100 Dollars (\$100.00).

(b) Each application for the issuance of a city stormwater discharge permit for a new industrial or commercial facility (including but not limited to a permit for the development of a residential subdivision) shall be accompanied by a nonrefundable fee of One Thousand and No/100 Dollars (\$1,000.00) plus Fifteen and No/100 Dollars (\$15.00) per acre

Said fee is good for one year and can be renewed for one additional year for a cost of One Hundred and No/100 Dollars (\$100.00)

(c) Each application for the issuance of a city stormwater discharge permit for a residential facility (i.e. a residence, not a residential development) shall be accompanied by a nonrefundable fee of Five Hundred and No/100 Dollars (\$500.00) plus Fifteen and No/100 Dollars (\$15.00) per acre

Said fee is good for one year.

Section 2: That all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 3: That this ordinance shall become effective as provided by law after passage, approval and publication.
