CHARLES KESSLER REQUEST TO REZONE: PARCEL 1 (4.58 ACRES) FROM AG-1 TO B-3, PARCEL 2 (22.37 ACRES) FROM AG-1 TO R-2, LOCATED OFF MOODY PARKWAY AND FURTHER IDENTIFIED AS ST. CLAIR TAX ID# 24-09-31-0-001-009.000. *Stipulations: 1) R-1 Homes in R-2 zoning, 2) 30% masonry or brick, 3) Homes must be of same style presented in Exhibit A.* Motion was made by Council Member Lynn Taylor to approve. *With the contingency or the re-survey being completed (signed, filed at the JOP and returned to David Crowe, Building Inspector for approval.)* Motion was seconded by Council Member Linda Crowe and all present voted AYE: Motion was carried by unanimous vote.
